Vermont Veterans Home Recognizes BENNINGTON P.A.C.T. 16 August 2013



On the afternoon of 16 August, four of the six members of the USS Bennington PACT (LT Mike Ponto, FTG2 Tom Ganse, SK3 Joe Pires and ABEAN Al Becker) once again provided a picnic for all veterans at the Veterans Home in Bennington, VT. They also presented a \$350.00 check to the Veterans Home Administrator, Melissa Jackson, for the Members Assistance Fund. That fund is utilized for assisting the veterans in their personal needs.

During the event, Army Colonel (Ret.) Joseph Krawczyk (President, Board of Directors), Marine Corps Colonel (Ret.) Al Faxon (Assistant Administrator) and Vermont State Republican Representative, Mary Morrissey asked that the four members of the Bennington PACT to please stand and be recognized. Colonel Krawczyk then presented each of them with a challenge coin stating, "For your personal dedication, teamwork, serving our veterans here at the Veterans Home in Bennington, and for fulfilling your promise in so many ways, to make a difference, I'm honored to present you sailors with this challenge coin for remembering our veterans". Once the presentation was over, the PACT members headed to the rooms of the veterans, to engage in conversation with fellow veterans (male & female) from all branches of the military.





Each year in August, this group heads to Bennington, VT to participate in some local activities during Bennington Battle Day Weekend Festivities. Fridays of that week are for feeding the vets. On Saturday afternoon a memorial wreath laying ceremony for our recently departed shipmates, Marines and airmen is held at the Ship's Bell Monument and on Sunday, this group participates in the Bennington Battle Day Parade (in their Navy White Uniforms). After the parade, the VFW Post in Bennington hosts a luncheon for those who participated.



Secretary's Report - Long Beach, CA 2013

Our annual business meeting of the USS Bennington Association was held at 0900 Sept 28 2013 onboard the Queen Mary at Long Beach California.

President Copeland called the meeting to order and asked all WWII veterans to please stand and be acknowledged. President Copeland asked all first timers to stand and be acknowledged. President Copeland then asked for a moment of silence for our departed comrades.

President Copeland then called on Vice President Ralph Clark.

Vice President Clark gave greetings from some shipmates that were unable to be here, Mr. & Mrs. Peckson, Phyllis Easley and Patsy Quinn. He also announced that the ship's store would be closing at 1pm today and will not reopen. Vice President Clark asked that all print legibly on the photo cards and photos would be taken from 4 to 6 pm with group photos taken after the banquet. He also welcomed all first-timers. Vice President Clark also asked everyone to wear their Bennington caps and jackets whenever you can so we can get new members, advertise, and advertise!

President Copeland then called on Secretary Loren Weers for his report.

Secretary Weers read the minutes of the St Louis reunion. Secretary Weers then read some correspondence received in the last year including a letter with a USS Bennington patch received from a USCG RM2 who got it at Gitmo in 1964. Another from Jack Capp YNC and another from John McCoy's son with citation issued for heroism during the explosion at Newport RI in 1954. Secretary Weers also received copies of a letter from Ernie Davis to his pilots' parents in 1945, and a letter from the attorney for Donald Stevens' estate with a check for \$300 for the USS Bennington Association. All these correspondence and patch were forwarded to Joe Pires our Historian for inclusion in the Bennington memorabilia. Motion was made and seconded to accept the Secretary's report.

President Copeland then called on our Treasurer Mike Ponto for his report.

Treasurer Ponto read his report and also reported that \$1480 was from the Bennington Exchange run by Allan and Audrey Zerfas. Treasurer Ponto stated that our \$1M insurance policy excludes the serving of alcohol which is one of the reasons the board has decided to have staff bartenders provided by the venue from now on. We purchased a wreath for the Bennington Memorial at Newport twice a year, Memorial Day and Veterans Day and a wreath at Bennington Battle Days every year. Motion was made and seconded to accept the Treasurer's report.

Treasurer Ponto advised that the board has recommended the dues be raised to \$25 per year to keep our organization self-supporting. After a lengthy discussion the motion was made and seconded to raise the dues and change the by-laws to show the dues at \$25.

Bill Coughlin made a motion that the By-Laws be accessible to the membership. Bill was advised the By-Laws are on the website and will be updated and for anyone who does not have computer access they could contact Treasurer Ponto and he would mail a copy to them.

Lifetime membership was discussed and after much discussion it was decided that a person could pay their dues in advance, but we will continue with no lifetime option at this time.

The group breakfast before the business meeting was brought up for discussion including the cost and after much discussion the motion was made by Doug Madison and seconded to eliminate the breakfast and start the business meeting at 10 am giving everyone time to have breakfast on their own,

President Copeland thanked Bob Holmes and Chief Rich Johnson for all their work putting the Long Beach reunion.

President Copeland called on Bob Shurmer to give a run-down on the upcoming reunion in Gatlinburg.

President Copeland asked for any suggestions for our 2015 reunion. Mike Ponto suggested Annapolis, MD; Loren Weers gave a presentation from Marv & Bobbi Itzen for Omaha, NE; Steve Leeds suggested Pensacola, FL; Rich & Etta May Boyd suggested Richmond, VA; and Boston, MA was also suggested. After a run-off Pensacola, FL was chosen for our 2015 reunion.

Treasurer Ponto held a drawing for \$50 gift certificates for the Bennington Exchange. The winners were: George DeJong, Mac Smith, Loren Weers, Tom Christenson and Roger Copt. The certificates were donated by Alan & Audrey Zerfas and the Association earned \$300 from the sales for this raffle.

Don Miller presented seven framed pictures of the Newport RI Memorial to the .Association. These were forwarded to Joe Pires our Historian for inclusion in the Bennington memorabilia.

Vice President Clark issued a welcome back to George & Marge Britt.

With no further business, President Copeland closed the meeting.
